



Northern California Sled Dog Rescue (NorSled) Foster Agreement

This agreement is made and entered into this _____ day of _____ 201____ by and between Northern California Sled Dog Rescue (NorSled) hereinafter referred to as NorSled and the individual(s), listed below hereinafter referred to as Foster Parent. This agreement holds binding for any and all future dogs fostered for NorSled, even if there is a hiatus between fostering.

Foster Parent understands that NorSled does not have complete prior knowledge of the rescued dogs' health and temperament, and I shall take all necessary precautions to protect myself and others who might come into contact with the dog(s).

Foster Dog(s) is not to be transferred from the Foster Parent to any other party without prior approval from NorSled.

Foster Dog(s) shall never be abandoned, sold, given away or turned over to a shelter.

Foster Parent will notify NorSled of any contact changes (address, phone number, email) within 24 hours of change.

Foster Parent will notify NorSled immediately if Foster Dog(s) gets loose and is missing.

Foster Dog(s) remains the property of NorSled while in Foster care. The Foster Dog(s) will be surrendered immediately upon the request of NorSled. Should legal action be necessary to reclaim a Foster Dog(s), the Foster Parent will pay NorSled any and all expenses, including court costs and reasonable attorney's fees, in enforcing the terms of this Foster Agreement.

Foster Parent will carefully review the NorSled Members Manual found on the NorSled website www.norsled.org (listed on the right hand column of the "Resource" tab) and will comply by the rules & regulations set forth in this manual. Requirements for fostering are clearly outlined and must be adhered to. Foster Parent will ask a Board member any necessary clarifying questions before taking any dogs into Foster Parent care.

RELEASE STATEMENT

Foster Parent shall not hold NorSled liable, or responsible for, and NorSled shall be saved and held harmless from and against any and all claims and damages of every kind, for injury to any person or persons, and for damage to or loss of property arising out of or attributed to, directly or indirectly, the operation or performance of NorSled and any of its Board Members, Officers, Fosters, Volunteers or members under this agreement, including claims and damages arising in whole or in part from the negligence of NorSled.

Foster Parent Hereby releases NorSled and all its Board Members, Officers, Fosters, Volunteers and any other members or Representatives from any and all responsibility with regard to Fostering, which the Foster Parent undertakes voluntarily and with full knowledge of the above release and its implications.
